Sub: Medical Services -Action Plan - Reg.

The following action plan for Medical Services in the State of Telangana is proposed for implementation immediately:

1. All District Presidents/Executive Presidents are requested to nominate District Medical Coordinator before 30.9.2018. The details may be sent to the State Medical Coordinator with a CC to the State President, Telangana.
2. The District Medical Coordinator is not gender specific responsibility. Any competent male or female who are interested in medical service can be nominated. The District Medical Coordinators shall perform their duties and responsibilities under the guidance of the State Coordinator/State President.
3. There are five medical **mobile vans** in Telangana state as under:
Hyderabad, Khammam, Nagarkurnool, Mancheriyal and Rangareddy+ Medchel.

These six districts must conduct Mobile Medical camps at least once in a month without fail.


4. The districts having Mobile Medical vans, must plan Uni-Speciality camps viz. Eye, ENT, Gynaec, Cancer Awareness Programs, Cardiac camps, Awareness on Joint Replacements programs etc. in consultation with the State Medical Coordinator.
5. At least one Mega Medical Camp may be planned every year in all the Districts.
6. Necessary action may be taken immediately in the 16 Districts, which are not having a single medical clinic and requested to start atleast one clinic before Bhagawan's 93rd Birthday Celebrations i.e. 23.11.2018.
7. High priority must be given for all the follow up cases. Every follow up case identified during the mobile camps, mega medical camps and uni-speciality camps must be reported to the State Medical Coordinator, Telangana.
8. Each District must have a dedicated team of sevadal members for attending follow up cases regularly and report the matter to the State Medical Coordinator.
9. All District Presidents/Executive Presidents are requested to maintain a list of doctors attending the medical seva in their districts and send the same to the State Medical Coordinator immediately.
10. Doctors in the Districts must be invited for all the important functions and honoured suitably.
11. Every Medical seva undertaken in the District/Samithi/BhajanMandali must be reported to the State Medical Coordinator through MEDICAL APP or mail.
12. Sri Sathya Sai Aarogya Pradayani, a quarterly All India Medical newsletter was launched at Prashanthi Nilayam in the year 2017. We shall also contribute our medical reports to this News letter through the State Medical Coordinator with 2 to 4 high resolution photos.

Sri G. Bhaskara Rao, Hyderabad, State Medical Coordinator, Telangana will be available for clarifications and guidance on all matters related to Medical services. He is requested to extend all the necessary support in this regard.
